Jenny's background is finance and numbers and she was always scrutinising WHA financials at board meetings. She always gave sound financial advice when needed, which contributed to the way Waikato Hockey sets their budgets and manages their finances each year.

Thank you for your service Jenny it is very much appreciated. During the year we also said goodbye to Heather Junge who was the Waikato Hockey Charitable Trust representative on the WHA Board and Bevan Sam who was elected in 2022. In 2023 Waikato Hockey's year was finally a hockey season uninterrupted by Covid! The year kicked off with Waikato Hockey sending eight teams across to Tauranga for Masters tournament. Thank you to Tauranga Hockey Association for hosting a fabulous week of hockey.

2023 was a year of reflection and growth – an opportunity to build on the experiences of 2022 and strengthen our foundation for a prosperous future. The year commenced with the appointment of Craig Webber as CEO, heralding a period of significant transformation within the Association, as detailed in this report. As 2023 drew to a close, Craig moved on from working with Waikato Hockey. Subsequently, the WHA Board entrusted me with the role of Interim CEO.

The winter season was a success with continued increase in team numbers in the Senior divisions and across school hockey. Waikato Hockey hosted the National Hockey Championship, where four local teams entered, Waikato also sent teams to several agegroup Regional and National tournaments and festivals held across the country throughout the year.

#### Growth in our Hockey Community has been seen in the following areas:

- Primary (Rainbow increase 5 teams; Mini increase 13 teams)
- Secondary (3 more teams)
- Club Seniors (3 additional teams)
- Overall saw an increase in Winter player numbers; 2022 total 4365; 2023 increase to 5089 players.

#### **Events for 2023**

- The Just Hockey Festival marked Waikato Hockey's first pre-season event, serving as a fantastic season opener.
- During Easter, Waikato Hockey hosted the NZ Heritage Hockey tournament, featuring an exhilarating weekend of hockey with teams such as the NZ Maori, Indian, Maori Juniors, and NZ Pasifika.
- The Rural Schools tournament, held to conclude the season, has become a popular festival for children in years 3 to 8 from country schools.
- Waikato Hockey participated in various age group events, including the u16 Northern Region Grant McLeod Festival (special thanks to North Harbour Hockey for hosting) and the Year 7/8 McGrath Festival (gratitude to hosts Rotorua Hockey).
- Throughout the season, Gallagher Hockey Centre organised multiple programs, camps, and holiday activities.
- Last but not least, hosting the Ford National Hockey Championship was undeniably one of the season's highlights.



Waikato Hockey hosted one of Hockey New Zealand's (HNZ) largest tournaments - Ford National Hockey Championship (NHC) – help in September. Over 32 teams from around the country attend this spectacular event. It was great to see local supporters at Gallagher Hockey Centre and St Pauls cheering on not only the Waikato teams, also watching other Association teams throughout the weeklong tournament.

A special thanks is necessary for our volunteers for the working bee we held before the tournament to prepare and to the volunteers we had throughout the week, especially to our turf watering crew Bruce Rosemergy, Peter Cawkwell, Des Meads and Alastair Kerr.

#### **Grant Funding and Sponsorship**

In 2023 the way in which our funding is applied for changed, bringing on a third-party to assist with grant applications. Waikato Hockey was able to secure funding for new scoreboards, dugout extensions, upgraded sound system, in-school programs, umpire growth, funds towards running costs and hirage costs of satellite turfs for school hockey. Thank you to the funders who have helped to upgrade Waikato Hockey's facilities and support the running of hockey over this period. Thank you Grassroots, Tu Manawa, Lion Foundation, Trust Waikato, Four Winds, Pub Charity, Aotearoa Gaming Trust, Trillion Trust, WEL Energy, TAB NZ Racing Board and One Foundation.

Thank you to the sponsors of Waikato Hockey Association and Waikato Hockey Charitable Trust, they continue to dedicate financial resources, time and expertise in helping hockey develop in our region. Waikato Hockey Charitable Trust re-secured Gallagher as the main sponsor of the Hockey Centre, remaining naming-rights sponsor of the Gallagher Hockey Centre at Queens Avenue, Hamilton.

Prior to their departure from Waikato Hockey, Kris Anderson and Craig Webber secured New World Te Rapa and Lugtons as turf naming-rights sponsors in late 2022. Thank you to both organisations for your continued support of Waikato Hockey. We are looking forward to developing our relationship further.

In 2023 naming rights sponsorship was secured for the dugouts at Gallagher Hockey Centre. Dugout sponsors are Bayleys, Just Hockey and Culswick Construction. Due to the significant funding from Grassroots, one dugout was named for them.

#### **Challenges presented to Waikato Hockey**

As with every organisation there are still challenges. The Association is no different. This includes continuing the financial stability, developing premier hockey and maintaining the growth in our sport within the Waikato. Financially Waikato Hockey is recovering from ever increasing costs and is working hard on building the Association back to the financial status the organisation was once in 2020, where the rainy-day funds helped the organisation get through the Covid times.

With a cost-of-living crisis looming the Association is reviewing all aspects of the organisation to help hockey to continue it's growth and improve facilities to sustain this growth. Our senior Premier hockey is going under the microscope in 2024, as numbers continue to dwindle and Clubs struggle to attract players, questions and reviews need to be made in this space. The Association has plans in place to work with neighbouring Associations, clubs, players and coaches to find out how this competition can be improved.

#### Café refurbishment and the enhancement of the pavilion

Renowned for its delectable hot chips, our cafe's renovation project, spearheaded by Craig, has garnered significant popularity within our community. The establishment was named The Final Whistle Café in 2023. From 2022 to 2023, the operational responsibilities were initially managed by Vicki Laing, later transitioning to Jamee Webber. In conjunction with the refurbishment, enhancements such as menu revisions, strengthened supplier connections, and an overall elevation of the cafe's ambiance have been achieved through the dedicated efforts of our cafe team.

#### Highlight of achievements in our community include:

- Starting the year with a silver medal for our Women's 50s and bronze for 45s Women's team at Masters.
- Future Black Sticks playing at the Junior Hockey World Cup in Chile (Women) and Malaysia (Men). Proud to see local players Leah Hodges and Luke Aldred represent NZ.
- Our resident umpire development manager, Bevan Nichol, starring at the Men's Junior World Cup as an Umpire.
- Volunteer of the year! Richard Baggs for being awarded this Hockey New Zealand award for 2023.
- Indoor hockey Our coaching superstar Reiner Vellinga went to Malaysia as Men's head coach where the team came home with a Bronze medal. Reiner also coached during the Indoor World Cup in February, an accomplishment to be proud of.
- Reiner and Bevan both became FIH accredited Coach/Umpire Developers in 2023.
- Ethan Hohneck for heading to Oman for the inaugural FIH Hockey 5s world cup as manager of the New Zealand Hockey 5s Men's team.

#### Waikato Hockey taking on new Hockey New Zealand initiative

Waikato Hockey Association took on the Lead Association role for the Middle North Catchment area (Thames Valley, Waikato, Tauranga, Bay of Plenty) for Hockey New Zealand's new initiative announced in 2023. This saw Waikato Hockey appoint a Connected Network Manager, Claire Rusk. The initiative will see Regional Associations work together to collaborate on all aspects of hockey to share knowledge and workloads all in the name of growing and developing the sport we are all here for.

#### The team that run the Association!

Thank you to the team at Waikato Hockey Association for continued dedication to grow and develop hockey in our community. The year ahead will see some changes on deck here.

In the hockey development space for 2024 there is some change. Reiner Vellinga taking on a new Coaching Development role; Nicky Smith continuing Hockey Development Manager with additional responsibilities as Pathway lead; Ella Leighton supporting the Hockey Development team as Community Officer. The development team ran a free performance program in 2023 for our high-performance athletes and are building on this in 2024 to not only grow our athletes with further opportunities, Nicky and Reiner are developing a program that has financial stability for the future.

Reiner and Nicky have several years working together prior at Midlands, having them both at Waikato Hockey to implement their knowledge is an asset to our community, players, and coaches. Ella has flourished as Community Officer in 2023, developing her skills on the turf as coach and around the office developing programs.

Umpire Development will continue to grow as Bevan Nichol takes the lead in education and mentoring across the region and all the competitions. Implementation and development of the new Whistle Up program for umpires will be the focus of 2024. 2023 was the first for Waikato Hockey to have a dedicated Umpire Development Manager and this new position created a lot of change around Waikato Hockey, including implementation of new policies and code of conduct, all due to Bevan's dedication to the sport.

Competitions is Nathan's area of expertise, figuring out how many rounds, crossovers and alike is his forte. In 2023 Nathan became Waikato Hockey's PlayHQ guru, as the Association implemented the new competition software.

Bruce keeps our facilities in top shape for all our members, tireless hours setting up turfs to painting our stands red, yellow and black!

Last but not least, the Finance team - Kirsten Brinkworth has a vast knowledge of Waikato Hockey Association, ticking over 19 years early in 2024, I would like to take this opportunity to Thank Kirsten for her dedication to ensuring the sustainability of Waikato Hockey. In 2024 Vicki Lahana joins Kirsten in the finance team, to support and reduce the pressure for many behind the scenes functions.

I would also like to take the opportunity to thank the WHA Board for your dedication to the governance and over-seeing the direction of Waikato Hockey. As new Board members are welcomed this year, new ideas and new visions will be noticed throughout the community.

2024 is going to see a lot of reviews, strategy development and research completed to help shape the future of hockey within the Waikato. An exciting year ahead that I am proud to be a part of, as I head into my sixth year at Waikato Hockey Association.

# HOCKEY DEVELOPMENT REPORT

2023 was a year that saw a lot of new faces in the WHA hockey development staff and all for the better! With the new input from Nicky, Ella and Ben we have been able to spend more time on and around the turf where needed, improving the overall player experience.

The Rainbow Hockey program, (year 1-2's) continued to grow filling our 2 turfs every Saturday morning led by Ben and Ella. The Mini and Intermediate hockey competitions also grew in numbers this year, which is the second year running since covid.

The U12 and U14 Development Programs and Camps ran again this year. The Development Program was run throughout all terms and again we used the Boys High turf during term 2 and 3 to allow all the hockey to fit on the turfs. The Development Camps were run in the April and October holidays with high uptakes.

The U16 age group had double opportunities again. We continued hosting an U16 Tri series in July and also attended Northern Region's Grant McLeod U16s Festival in North Harbour. The Tri series is an opportunity for our Development Program players to extend their development with game play to continue their learning. The Grant McLeod festival was an opportunity for all of our U16 players (plus our Yr 9 age group) to join a massive festival with all their peers. We sent two girls and two boys 11-a-side teams and even took out the Win in the Development Boys grade. We again took multiple 5s teams to the event which is a really fun, developmental event. It was huge success and we are looking forward to teams attending again next year.

The Waikato Wintec U18 girls had their National Tournament in Auckland. The girls found themselves in an extremely tough pool with eventual finalists North Harbour and Canterbury. The opening game against North Harbour was a close one with our girls only conceding the 2-1 five minutes before the final whistle. A win against Auckland lifted the moral again, but eventually a loss against Canterbury meant our girls missed out on quarter finals. A shoot out win over Central Otago, a loss against Northland and a victory over Wellington saw the girls finish 11th overall.

The Wintec U18 boys were met with some snowy conditions in Dunedin. The guys managed to top their pool after beating Thames Valley and North Harbour and drawing with Hawkes Bay. The quarter final against Tauranga had our rivals finish on top. Another draw with Hawkes Bay and a loss to South Canterbury meant the boys finished 6th overall.

The National Masters Tournament finally took place again in 2023. We had 6 Waikato teams and a Kaimai team go to Tauranga to defend the Waikato tri-colors. The women's 50+ finished at a solid 2nd place and the women's 45+ finished at a mentionable 3rd place.



# HOCKEY DEVELOPMENT REPORT

The National Hockey Championship was on our home turf. With NHC coming to our doorstep we had 4 teams competing across both tiers.

The Bears played in tier 2 and played some great hockey. With the results not always going the way they should the men finished on a winning streak beating BOP, Wellington and Otago and had to settle for 9th out of 12.

The Waikato men in tier 1 played some of the most amazing hockey throughout the week. Former winner Otago was beaten on in a shootout and North Harbour and Canterbury were kept at a draw in the winner's pool. The results unfortunately kept our guys out of the final and whilst playing for Bronze they had no luck beating Harbour a second time.

Our Wildcats started with a win over Southland, but didn't manage to back up this success again. Although always in close games and great contest the girls finished 9th. The tier I women started the tournament with a cracker of a game against Manawatu losing by the smallest of margins in the final quarter. As the week progressed the girls started to struggle to keep up the high energy levels they showed before and went towards the tail end of the tournament. In the final weekend they managed to secure two well deserved wins over Otago and finished 7th.

The indoor championships took place in November. The men's team was a stacked one with Black Sticks and Indoor Internationals playing alongside each other. In the final the men conceded to Harbour again like last year and had to settle for silver.

The U18 girls had a fantastic tournament winning silver in a round robin tournament. A very young U18 boys finished 6th overall with a good demonstration of potential for the future. A mixed masters 40+ team entered the men's competition and should be very proud of their final result finishing 2nd in their age group.

Rural schools tournament took place in September over three wonderful days. Weather was good, hockey was better. Great attendance by our Rural schools made for a really awesome three days of hockey.

We are now in our third year of the Hockey without Limits program. Hockey without Limits focusses on children age 5-11 years with disabilities. The initiative provided students an opportunity to play hockey weekly, finishing with a festival at the end of the term. The Initiative was a great success and enable these students to have a go at hockey removing the common barriers. This was a Tu Manawa funded initiative which enabled us to leave hockey equipment behind so schools can continue to enjoy playing hockey.

In 2023 we also played a role in bringing a successful multisport initiative together. In collaboration and partnership with other codes within the Waikato region, we were involved in delivering Multi sport Holiday programmes providing our tamariki the opportunity to experience hockey and other sports over two days at one venue. The programme was a huge success and recognised at the Sport Waikato Active Recreation Awards, winning the Partnership Award.

2023 saw a lot of great improvements within our programmes and in 2024 we will aim to continue this. We will continue to improve our development programs and we will make a strong push to deliver more coach development.

# UMPIRE MANAGER REPORT

## Leadership and Commitment from Waikato Hockey to Resource Umpire Development

In 2023, the Association took the largest steps forward in umpire development and support in its history. This came through the instatement of:

- A .5 FTE 'Umpire Development and Pathways' position;
- A space dedicated to an umpire's room;
- Appointed umpire and technical official payments increased to \$25 per game;
  - Appointed umpire coaches matched at \$25 per game;
  - A resourced appointments person for Sunday competitions;
  - Upgraded and increased number of umpire radios;
  - New umpire shirts for all appointed umpires; and
  - New jackets for active umpire coaches.

#### Waikato Hockey recognised as a Nationwide Leader

This season's leadership and commitment has had a profound impact on the experience of umpires at Waikato Hockey, and on our competitions. The Association's progress has been applauded and held up as a nationwide leading example in many contexts by Sport Waikato, Hockey New Zealand, and Auckland Hockey Association.

#### Bevan Nichol Appointed as 'Umpires Development and Pathways Manager'

Waikato Hockey was pleased to announce the appointment of Bevan Nichol as Umpire Development and Pathways Manager having been a local player and umpire for more than 20 years. He has worked from the grassroots level to the rank of international umpire and been appointed to umpire at Hockey New Zealand's premier national tournaments for 10 years. He is an active umpire coach within the Hockey New Zealand Development Pathway and accredited by the Federation of International Hockey as an Educator and Coach Developer.

#### **Association led 2023 Priorities in Umpire Development**

**Through** strong and active collaboration between the Umpires Development Manager and the Chief Executive Officer, five key priorities were set for the season:

- 1. Review, update, and bring WHA's Code of Conduct and Judicial documentation/processes up to national standard;
- 2. Develop and facilitate a functional officiating Governance Structure;
- 3. Create a training and development pathway for umpires and umpire coaches;
- 4. Increase capacity and capability of umpire and umpire coach community; and
- 5. Promote and celebrate officiating community commitment and achievements.

# UMPIRE MANAGER REPORT

#### **Association's Goals for its Competition Environment**

This season we took a zero-tolerance approach toward misconduct and umpire abuse as we endeavoured to recruit, support, and retain umpires across all grades, to improve our overall Hockey product and experience for all participants. To do this, we were motivated to create competitions that are positive and enjoyable for all.

#### Review of Waikato Hockey's Code of Conduct and Judicial Processes

After a review of Waikato Hockey's Code of Conduct and judicial processes (last reviewed in 2012), five recommendations were made to the Waikato Hockey Board who approved and implemented them for the 2023 season. In collaboration with the Board, the Association:


- 1. Adopted the Hockey New Zealand Code of Conduct for Associations, and used it to manage the conduct of all participants in our competitions;
- 2. Designed and implemented the 2023 Misconduct and Umpire Abuse Policy;
- 3. Announced and promoted umpire and community guidance on the use of penalty cards;
- 4. Appointed a judicial committee and chairperson; and
- Adopted a simplified complaints process which uses the Hockey New Zealand Code of Conduct guidelines on process for hearing and determining any complaint, protest or appeal.

#### **Community Leadership, Engagement and Support**

Thorough and regular engagement was undertaken with our senior competition community and we want thank the teams, coaches, managers, captains, and Club Presidents who proactively managed and helped us move toward our goals for a positive competition environment.

#### **Umpire Post-Season Survey**



Waikato Hockey receives grants and sponsorship. Hockey teams pay fees to play in the competitions. Revenue is provided from the Cafe, and Hockey Coaching Programs. Income is generated to fund the Representative Program, which also incorporates fundraising.

Waikato Hockey would not be able to run without the many volunteers who, coach, umpire and assist to run Hockey games, competitions and tournaments.

# **Statement of Accounting Policies**

### Waikato Hockey Association Inc For the year ended 30 November 2023

#### **Basis of Preparation**

Waikato Hockey Association Inc has elected to apply PBE SFR-A (NFP) Public Benefit Entity Simple Format Reporting - Accrual (Not-For-Profit) on the basis that it does not have public accountability and has total annual expenses equal to or less than \$2,000,000. All transactions in the Performance Report are reported using the accrual basis of accounting. The Performance Report is prepared under the assumption that the entity will continue to operate in the foreseeable future. The Association is not required to complete a Statement of Service Performance and has elected not to do so

#### **Historical Cost**

These financial statements have been prepared on a historical cost basis, except where otherwise indicated.

The financial statements are presented in New Zealand dollars (NZ\$) and all values are rounded to the nearest NZ\$, except when otherwise indicated.

#### Goods and Services Tax (GST)

The entity is registered for GST. All amounts are stated exclusive of goods and services tax (GST) except for accounts payable and accounts receivable which are stated inclusive of GST.

#### Income Tax

Waikato Hockey Association Inc is wholly exempt from New Zealand income tax under section CW46 of the Income Tax Act 2007, having fully complied with all statutory conditions for these exemptions.

#### **Bank Accounts and Cash**

Bank accounts and cash in the Statement of Cash Flows comprise cash balances and bank balances (including short term deposits) with original maturities of 90 days or less.

#### **Changes in Accounting Policies**

There have been no changes in accounting policies. Policies have been applied on a consistent basis with those of the previous reporting period.

#### Fees Income

Fees and Subscriptions are received in exchange for monthly access to facilities and recorded as income in advance and recognised in revenue evenly over the membership period. Where members purchase specific services (for example, attendance at the coaching and development courses), revenue is initially recorded as revenue in advance, and then recognised proportionally on the basis of the value of each session relative to the total value of the purchased services. Other fees and subscriptions are recorded as revenue when cash is received.

#### **Grant Income**

Grant Income which contributes to revenue is recognised in the Statement of Financial Performance as soon as any obligation to those grants have been met.

#### Inventory

Inventories are stated at the lower of cost and net realisable value. Cost is based on first-in-first-out basis.

#### **Operating Lease**

Operating lease payments have been included as an expense in the statement of Financial Performance in the periods in which they are incurred.

#### **Accounts Receivable**

Accounts Receivable are stated at their estimated realised value.

#### **Accounts Payable**

Accounts Payable are stated at the invoiced amount.

#### Depreciation

Depreciation is provided on a straight-line basis on all property, plant and equipment, at rates that will write off the cost of the assets to their estimated residual values over their useful lives. The Association has opted to depreciate in full all of those assets purchased after the end of March 2020 being of a value under \$5,000, as per IRD ruling. The depreciation rates and useful lives associated with major classes of assets have been estimated as follows:

#### **Employee Costs**

Employee entitlements are measured at undisclosed nominal values based on accrued entitlements at rates of pay. These include salaries and wages accrued up to balance date, annual leave earned but not taken at balance date.

#### **Wages and Salaries Expense Policy**

Wages and Salaries are classified by position based on experience, responsibility, physical and mental demands. The salaries are reviewed annually against CPI and adjusted accordingly.

#### Income in Advance

When income is received for a period of time, that income for the future time period is recorded as income in advance.

#### Interet Income

Interest Income is recognised on an accrual basis.
